ANNOUNCEMENT OF PDE SCHEDULE FOR 2026/2027

This serves to advise stakeholders of the following PDE dates for the calendar year 2026 and financial year 2026/2027. All property practitioners who still need to complete PDE are advised that PDE registrations are strictly completed online via MyPPRA Portal.

The following are proposed dates for the conduct of PDE during 2026-2027 financial year:

Important Considerations:	Professional Designation Examination (PDE) registration or enrolment: <ul style="list-style-type: none"> • PDE registration or enrolment must be completed strictly via the MyPPRA Portal. • No manual registration or enrolment forms (including any previously used forms in the possession of exam candidates or archived by the PPRA) will be issued or accepted for any examination. • The venue address indicated either on MyPPRA Portal during the registration window and also on the letters confirming successful registration for the exam is for registration or enrolment purposes ONLY and does not imply that the examination will be venue-based or conducted 	

orally.

Examination Format:

- **All examinations will be conducted as take-home exams, unless otherwise communicated by the PPRA.**
- Detailed instructions for the take-home exams will be provided when and /or during the exam registration or enrolment process and for each examination. Examination candidates are encouraged to check the PPRA website for these instructions to ensure that they are aware of the requirements and processes for each exam. Exam candidates are also advised to read exam instructions carefully to ensure that they comply with exam rules.

Payment Requirements:

- Payment for PDE registration or enrolment must be made using the correct 7-digit individual reference number, payments must be completed by the specified closing date. No exceptions will be allowed.
- **Do not email payment proof to the PPRA. Payments made using the correct 7-digit reference number will automatically reflect on the PPRA's bank statements. Exam Seat Number.**
- An Exam Seat Number will be allocated to candidates who have registered and paid using the correct reference number.
- The seat number is used for uploading exam results and will be visible to successfully registered candidates on the MyPPRA Portal. Postponements
- All requests for exam postponement must be submitted in writing, accompanied by supporting reasons and documentation.
- Requests must be submitted at least 14 days before the scheduled exam date, failing which the candidate will forfeit the payment made.
- Requests submitted after the deadline due to unforeseen and well-supported circumstances will be considered and approved
